The legal effectiveness of the merger in question is set at 11:59pm on 31 December 2025; therefore, starting from that moment the incorporating company Kirey S.r.l., pursuant to art. 2504 et seq. of the Italian Civil Code, takes over, without interruption and with full rights, all assets and liabilities, in all active and passive legal relationships, shares, rights, licenses, authorizations as well as in all commitments and liabilities of any nature of all the incorporated companies at the deadlines and conditions originally provided.

As a result of this incorporation and pursuant to the current EU Regulation 679/2016 (GDPR), the company Kirey S.r.l. also takes over the ownership of the personal data already subject to processing by the incorporated companies, while the purposes and methods of processing remain unchanged pursuant to the information already communicated.

Following the above-mentioned merger by incorporation transaction, as of 11:59 p.m. on 31 December 2025, only Kirey S.r.l. is operational, to which reference must be made for any business relationship, even if it arose prior to that date.

In particular, invoices and any other tax document issued as of 1 January 2026 must be made out to Kirey S.r.l., with registered office in Milan (MI), Viale Francesco Restelli, no. 5, tax code and VAT number 06729880960, while the previous documents must on the contrary be in the name of the respective incorporated companies.
